CHECKING UP ON YOUR HEALTH REQUIREMENTS

Why am I receiving this email?

This message is a notice that Student Health does not have documentation of your immunization record required by the UI. You will need to submit these before you can register for next semester classes. Requirements for general, international, and health science students are listed here:

Undergraduate or graduate students:

You are likely receiving this email is because we do not have a valid record of your receiving the **required 2 Measles, Mumps & Rubella vaccines**. These are usually childhood vaccines and can often be found on school records, health department databases, or your medical record.

- The first MMR vaccine must occur on or after your first birthday.
- There must be 28 days between MMR vaccines.

If in reviewing your records you discover that you have only had 1 MMR, your MMR(s) on record do not meet the requirements above or you have no records of MMR vaccines you will need to get vaccinated for MMR. You could consider getting titers (a blood sample to check levels of antibodies) but these are costly and you might end up needing one or two vaccines anyway, if any of the three titers shows you are non-immune. International students:

you may be receiving this email because we need to conduct an in-person **Tuberculosis** Screening with you and/or we do not have a valid record of your receiving the required 2 Measles, Mumps & Rubella vaccines.

- The first MMR vaccine must occur on or after your first birthday.
- There must be 28 days between MMR vaccines.

If in reviewing your records you discover that you have only had 1 MMR, your MMR(s) on record do not meet the requirements above or you have no records of MMR vaccines you will need to get vaccinated for MMR or get titers drawn. To find out if you need a Tuberculosis Screening, please call the IMU Nurse Care Clinic at 319-335-1395 or email student-health@uiowa.edu with your name and student ID number if you are unsure which Health Requirements are missing.

Health Science Students:

Those who are formally admitted into one of the following programs (*Medical, Nursing, Dental, Physical Therapy, Pharmacy, Physician Assistant, Radiation Science, Athletic Training and Speech Pathology*) have additional Health Requirements due to their course of study and interaction with patients/clients. If your status in any of the above programs is "pre-" or "interest", please refer to the undergraduate, graduate or international student sections above, as you are not classified as a Health Science student yet, and don't need to meet the full requirements unless your course coordinators tell you differently. If you are a Health Science Student, please call the IMU Nurse Care Clinic at 319-335-1395 or email student-health@uiowa.edu with your name and student ID number if you are unsure which Health Requirements are missing.

How do I submit missing vaccine records or test results documentation?

Email pictures or scans of documentation, with your name and student ID number visible to: student-health@uiowa.edu

What if I need to have vaccines, tests or a Tuberculosis Screening performed, because I have not had them or cannot find documentation in my health records?

Please make an appointment with Student Health at 319-335-8394 for a Nurse Care Health requirements appointment at the main clinic in the Westlawn Building. Alternately, you can walk in without an appointment at our IMU Nurse Care Clinic, G-103 IMU. We are seeing patients Mon-Thurs 8:30 AM to 12:30 PM and 1:30-4:30 PM; Friday 9:30 AM to 12:30 PM and 1:30-4:30 PM. Please note that this location, Tuberculosis Screening must be completed by 12:30 PM & Titers must be completed by 4:00pm in order to reach the lab in time for processing.
